Description

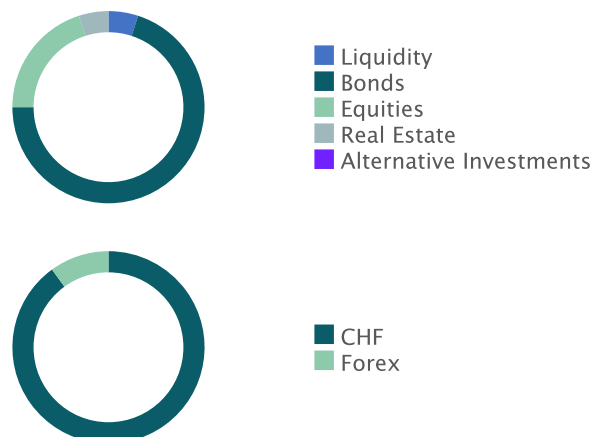

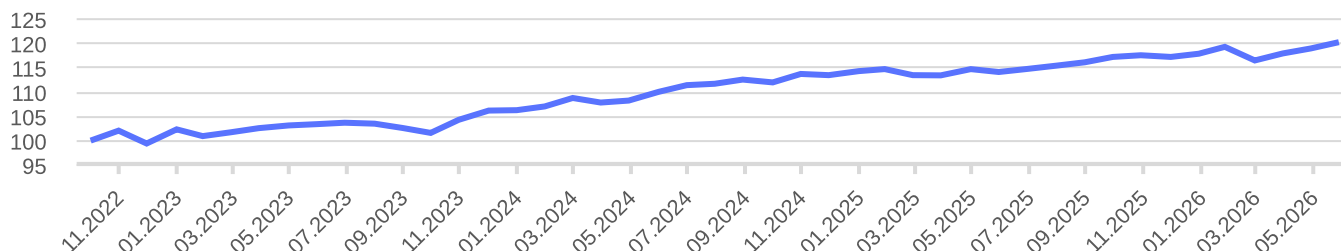

ESG

The funds used are committed to the "ESG approach", although there is no uniform approach to implementation. ESG stands for the aspects environment (E), social (S) and corporate governance (G). Engagement with companies is also often sought ("stewardship voting" / "engagement").
